For those who are unaware, effective December 1, 2023, the Regional Authority increased the amount caregivers are reimbursed for km to ¢.55. This applies to both km for the children in your care, and km for training (when applicable). Please turn in any unclaimed km you have ASAP in order for us to process them as quickly as possible. Child & Family Services New Foster Care Initiatives

- Easily accessible mental health supports for foster caregivers.
- Refer-a-foster caregiver.
- Foster caregivers caring for young adults.

Foster caregivers may experience many stressors as part of caregiving and their work with children and youth with complex care needs. CFS recognizes that counselling is a key way to support foster caregivers.

- Effective November 30, 2023, CFS will cover the costs of up to five one-hour counselling sessions per year (\$220 per session) per active foster care licence.
- Foster caregivers will have the option to access counselling with a professional already contracted through CFS or identify their own counselling supports (e.g., through Counselling Alberta) and be reimbursed.
 - Note: In order for foster caregivers to be reimbursed, counselling professionals must fall under the *Health Professions Act*.
- Prior approval is not required and you can access these services on your own; however, your foster care worker may need to be aware so they can assist with accessing the services if helpful.

CFS recognizes the recruitment efforts of foster caregivers. Foster caregivers know what makes an excellent caregiver and can see those qualities in their friends, family, neighbours and community members.

- Effective November 30, 2023, licensed foster caregivers will receive \$500 for each new foster caregiver they refer who successfully becomes a licensed foster home.
- Don't forget Pathways also contributes an additional \$250.00 for the referral bonus.


CFS recognizes the importance of continuing connections that have been made and to maintain long-term natural supports.


- The foster caregivers caring for young adults initiative will provide eligible foster caregivers financial compensation (daily skill fees/special rate) that align with the compensation foster caregivers received when the youth was under 18 and in their care. This recognizes the support and caregiving expertise foster caregivers provide to young adults who remain in their homes and are enrolled in the Transition to Adulthood Program (TAP). The new program is voluntary and the enrollment in the program will take place once an agreement between the TAP client and caregiver is signed.
 - The caregiver skill fee/special rate can be paid until the day before the young adult turns 22 as long as the young adult remains in the caregiver's home.
 - Room and board funding will continue to be provided to the TAP client and the young adult will pay the caregiver directly.
